- To canvas and to have programs for afforestation and ecological balance.
- To grant scholarships and freeships and free food to the poor and deserving students.

 - Advancement of any other object of general public utility and relief like conduction seminars on educational advancement, providing necessary assistance during natural calamities and such other assistance as may be required from time to time.
- 4. The Author of the Trust hereby sets apart a sum of Rs.5000/-(Rupees Five thousand only) to be held in truest as nucleus for the purpose of the truest.
- 5. The Trust shall be managed by the Trustees consisting of:
 - Sri A. SHANMUGASUNDARAM. S/o. T. Arthanarimudaliar, aged 55 years, residing at No.121/1, Velur Main Road, Nallur Kandampalayam, Paramathi Velur Taluk, Namakkal District.
 - ii) Sri. T. Arthanarlmudaliar, S/o. Venkatachalamudaliar, aged 85 years, residing at No.121/1, Velur Main Road, Nallur Kandampalayam, Paramathi Velur Taluk, Namakkal District..

- b) 1. Sri. A. SHANMUGASUNDARAM, Shall be the President & Secretary,
 - 2. Sri. T. ARTHANARIMUDALIAR, Shall be the Joint President,
 - 3. Smt. S.LEELA SHANMUGASUNDARAM, shall be the Treasurer
 - 4. Selvi. K.S. Vidhya, shall be the Executive Member.

The president and joint president both shall hold office for life or till voluntary retirement. In the event of the Office of the President & Secretary becoming vacant, the Joint president will take over as the President & Secretary. In the event of the Office of Joint president becoming vacant remaining Trustee may co-opt any one of them as the Joint president.

- c) The other Trustee shall retire by rotation in two at a time, the first to commence five years from the date of the Trust Deed. There tireing Trustees will be eligible to be co-opted for further periods.
- d) The President Trustees and the Joint President Trustee shall at their discretion co-opt any person/or persons who may be helpful in achieving the objects of the Trust as a Trustee.
- e) The Maximum number of Trustee shall not exceed eight.
- A Trustee shall cease to hold Office of Trust on the Trustee becoming insane or lunatic.

- g) The trust appoint the committee to run the institutions for the first five years are
 - 1. Sri. A. SHANMUGASUNDARAM, Shall be the President & Secretary for the institutions
 - 2. Sri. T. ARTHANARIMUDALIAR, Shall be the Joint President of the institutions
 - 3. Smt. S.LEELA SHANMUGASUNDARAM, shall be the Treasurer of the institutions.
 - 4. Selvi. K.S. Vidhya, shall be the Executive Member of the institutions.
- The Trust hereby created is not revocable at the instance of the Author of the Trust at any time and under any circumstances.
- The Trustees shall be competent and are hereby empowered to:
 - a) Receive any more and further assets in any shape or forth as and when given by the Author of the Trust, any of the Trustees or any other persons or institutions.
 - b) Collect funds by donations, subscriptions, grants, presents or contributions.
 - c) Invest the funds to the extent necessary in accordance with the provisions of Section 13(1) read with Section 13(5) of the Income Tax Act. 1961 or such other section of the Income Tax Act as amended from time to time so that the income of the Trust will be exempt for Income Tax.
 - d) Acquire on lease, purchase, or otherwise, sell, mortgage, lease out or transfer in any other manner properties (movable or immovable) construct buildings and effect other improvements for the purpose of the Trust.
 - e) Help and render relief to the poor in all possible way.




- Make donations or contributions for attaining and in furtherance of the objects
 of the Trust.
- g) Borrow for the purpose of the Trust on personal credit of the Trustees with or without charges or responsibility upon the assets of the Trust.
- Establish centres in different parts of the country for carrying out the objects of the Trust.
- 8. None of the powers enumerated above will be deemed to authorize the carrying on of any activity for profit by the Trustees and these powers shall be exercised by the Trustees in such manner that the income of the Trust will be totally exempt from tax under Sections 11, 12 and 13 of the Income Tax Act, 1961 or such other sections or clauses as amended from time to time.
- 9. All or any of the power vested in or exercised by a majority of the Trustees Present at the meeting of the Trustees and any action or decision of such majority shall be valid and effective as it would have been of done by all the Trustees.
- 10. The Trustees, if they so choose and for the benefit of the Trust may delegate by means of a resolution in writing any or all of their powers to any one or more of them or any other person for such time and purpose as they deem fit.
- 11. The Trustees shall elect from among themselves a Secretary, a Joint Secretary and a Treasurer and they shall hold office for a period of five years. The Trustees shall take charge for the Truest assets and hold and administer the same in accordance with the terms of this deed. All bank accounts shall be operated by the Treasurer jointly with the President of the Trust.




- The office of the president of the Trust shall be for life. One the death of the president, the person succeeding him shall hold office for life. The other Trustees shall hold office for a period of five years from the date of appointment or nomination as Trustees.
- 13. Any Trustees may, at any time resign his office of Trusteeship by giving one month's notice in wiring to his co-trustees and upon the expiry of the period, such Trustee shall be deemed to have vacated his office. The office of the Trustee falling vacant either by death or by resignation or expiry of 5 years period may be filled by nomination by the President of the Trust.
- 14. The meeting of the Trustees shall be presided over by the president of the Trust and in his absence, the Trustees present in the meeting shall elect one of them to preside over that meeting.
- 15. The Trustees shall meet from time to time as and when necessary to transact business and for considering the betterment of the Trust and its assets. The President of the Trust or the Trust of the President of the meeting as the case may be shall have a casting vote in case of equality of votes. Fifteen days notice of all meetings of the Trustees shall be given to all trustees either by Registered post or in any other manner as decided by the Trustees. The quorum for the meeting shall be one-third of the total number trustees. In case there is no quorum at the time fixed for the meeting, the meeting shall stand adjourned by half an hour and the Trustees present at the adjourned meeting shall form the quorum. The postponed meeting is entitled to transact its business without waiting for the quorum, but it shall not undertake any matter for consideration which is not announced in the agenda of regular meeting.



- The Trustees shall cause true and correct accounts to be kept of the sums of money and other assets received and expended on behalf of the Trust. Once at least in every year, the accounts of the Trust shall be examined and the correctness of the accounts and Balance Sheet ascertained by a Chartered Account appointed by the Trustees. The financial statements shall be counter-signed by the President, Secretary and Treasurer of the Trust.
- 17. The office of the Trustees will be honorary but the trustees will be entitled to be paid their actual travelling expenses and other incidental charges incurred by them in attending the meetings and inconnection with carrying out the objects of the Trust.
- 18. If for any reason, it is not possible to carry out the objects of the Trust, any assets remaining in the Trust shall be transferred to any other Trust or Institution or society whose objects are similar to the objects of the Trust.
- 19. The Trustees are wholly indemnified against any expenses or losses incurred or suffered in regard to any act, deed or omission of theirs in the performance of their duties as Trustees or any payments made by them in the administration of the Trust and such expenses, losses and payments made by them in the administration of the Trust and such expenses, losses and payments shall be borne by the Trust and none of the Trustees shall in any way be personally liable or responsible for the same.
- 20. The rules governing the administration of the trust may be amended by the Trustees with the permission of the Commissioner of Income Tax, so however, that the amended rules are not inconsistent with the object of the Trust and are not repugnant to the provisions of Section 2(15), 11, 12, 13 and 80-G of the Income Tax Act 1961, or such other sections or clauses as may be amended or added from time to time governing the activities or public charitable Trusts.


- 21. The benefits of the Trust shall be open to all irrespective of caste, creed or religion.
- The funds and income of the Trust shall be solely utilised towards the achievements of the objects and no portion of it shall be utilised for payment to Trustees by way of profit, dividend etc.
- 23. The trust may appoint any committee to run the institutions started by the trust as and when required.
- 24. In the event of the dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees but the same shall be transferred to another charitable Trust, society, association or institution whose objects are similar to those of this Trust and which enjoys recognition under Section 80-G of the Income Tax, 1961.

25. POWER OF TRUSTEES:

- a) To manage Trust Funds and collect and recover the interest, income and profits Thereof and to pay thereat the expenses of collection and other outgoing, if any.
- b) The Trustees shall have all power specifically conferred to do things as may be required for the proper conduct of the Trust and in the interest of the Trust, whenever, such powers are not specifically concened.
- a Bank Account or accounts in the name of the Trust or in the name of the School or Shools or Institutions at such Bank or Banks as they may from time to time decide and may at any time pay or cause to be paid any monies forming part of the Trusts Funds /School Fund or the income thereof to the credit of any such account or accounts either by way of Fixed or Current Account or any other account. Any such account shall be operated individually by President Trustee or Treasurer Trustee.




